CONTAMINATION CONTROL

Elimination of raw material contamination has been identified as the major factor of quality control. This is effectively tackled by adopting a three-pronged approach:

- Close interaction with each supplier to ensure conformance to pre-set standards of consistent, contamination-free cotton.
- Rigorous segregation of raw cotton at the ginning as well as mills to eliminate contaminated material.
- Installation of contamination remover at the Blow room stage and contamination clearer at the yarn stage to ensure purity of processed yarn.


